MA Appleseed's mission is to promote equal rights and opportunities for Massachusetts residents by developing and advocating for systemic solutions to social justice issues. We focus on three key policy areas: access to justice, educational justice, and youth homelessness.

Inequitable laws and policies perpetuate systemic racism, deny justice, cause preventable trauma in our communities, and create barriers that can be impossible to overcome. Marginalized community members are often denied their legal rights and opportunities because of these barriers. As a result, they can continue to face poverty and upheaval by the very institutions meant to provide a way out – our courts, schools, and government agencies. Our projects seek systems-level change so all families and youth can exercise their legal rights, build pathways out of crisis, and thrive. We respond to emerging and enduring inequities and address an array of complex issues, such as self-representation in the civil justice system, language access for immigrant families, the school-to-prison pipeline, and youth homelessness.

RECENT VICTORIES

- We investigated the harm cell phone bans at courthouses cause civil litigants who cannot afford an attorney and successfully advocated for the elimination of these unjust bans.
- We successfully advocated for \$165.5 million in state funding for an unprecedented investment in our court system that will ensure working families can solve their civil legal problems and achieve a fair outcome whether they can afford an attorney or not.
- We're co-leading the Mass Speaks Coalition and have mobilized community members to send more than 600 letters to policymakers urging action so hundreds of thousands of immigrant and limited English proficient families can access the services and information they need to stay safe, healthy, and stable.
- With coalition partners, we successfully advocated for the passage of the CROWN Act to ban discrimination against natural hairstyles and prevent the over-policing of Black and brown girls as young as five years old.
- We published the Massachusetts Homeless Youth Handbook, a comprehensive online know-your-rights guide for youth and young adults experiencing homelessness created with pro bono and community partners.
